<u>Noah Sedillo – Finance Director:</u> We had one bid from B & R Construction for this IFB 2023-01, one of two bids showed up late. This bid was publicly opened Monday February 6<sup>th</sup>, 2023, at 3:30 PM. The one bid was for \$1,244,015.30. With that we have a posted budget of \$675,000.00 for this project. I did provide for you liquid cash we have in our fund today from the PILT and American Rescue Act available to be used for this.

One of the late bids called to apologize for being late and stated their bid would have been well north of this bid.

**<u>Chairman Schwebach</u>**: This bid is twice what we had budgeted, I'm not ready to approve 1.2 million dollars. I know prices have increased since making this budget, but have we looked into making cuts to get closer to our budget?

<u>Noah Sedillo – Finance Director:</u> Yes, the discussions we have had with our architect and construction company with some of the modifications, there is not a significant change in the price. If the county could do the dirt work, we will incur the liability if something were to happen to the foundation.

Leonard Lujan – Road Supervisor: We have spoken to the architect and some things we can't change because then it won't meet the specs that have to be met. It needs to meet energy efficiency. We looked at it as we moved forward and did what we could or stop and wait and the bid may go up.

<u>Noah Sedillo – Finance Director</u>: This is with the current energy code in place. One of the main drivers of this cost is we have to pay wages for the labor because this is a public works project.

**<u>Chairman Schwebach</u>**: What is involved in the dirt work? Is the road crew capable of it?

**Leonard Lujan – Road Supervisor:** We can do it but if anything happens to the slabs then we are liable because we did the dirt work. Do we want to be liable on a new building?

**Commissioner McCall:** Concrete is going to crack; it doesn't matter what you do. We have the liability of you building roads with the public driving on them. The surface below the road department building is way down there when it comes to liability. I believe the county can do the dirt work

Chairman Schwebach: I'm assuming its prep work not foundation.

Leonard Lujan - Road Supervisor: Yes just prep work and compaction.

**Chairman Schwebach:** If we approve this, we are approving to enter into contract to not accede 1.2 million but have the ability to scope it down.

Noah Sedillo – Finance Director: That is correct.

Juan Torres – Deputy County Manager: We do not have the ability to phase it because the IFP was sent out for the entire project.

**<u>Chairman Schwebach:</u>** I want to move forward and think we can increase to a \$100,000 budget but want to see where we can make cuts.

<u>Commissioner McCall</u>: I agree and want to spend some time to see if we can make changes.

<u>Chairman Schwebach:</u> Motion to award IFB 2023-01 – County Road Department Construction to B & R Construction Co. Inc. of the bid not to exceed as bid presented.

Commissioner McCall: Seconds the motion.

<u>Chairman Schwebach:</u> At this point, if we approve this can we approach the contractor to discuss this?

Noah Sedillo – Finance Director: Yes

**Tracey Master - DWI Program Coordinator:** DFA has estimated we will receive \$120,741.00 in distribution funding for FY2024. The second column is the competitive grant request in the amount of \$108,207.00. The money will be allocated to the following components: prevention, law enforcement, screening, treatment, compliance, coordination, and alternative sentencing. The total amount budgeted is \$228,948.00. Application is due to DFA next Thursday.

**Sheriff Frazee:** NMDOT requested immediate action to allow state approval of Torrance County Sheriff's department, scheduling patrols as soon as possible. This was accepted and reviewed by the Sheriff's department, County Manager and County Attorney in the amounts of ENDWI - \$6,048.00; BKLUP - \$2,814.00; STEP - \$3,066.00 totaling \$11,928.00 This is an ongoing grant and expect to receive this annually.

Leonard Lujan – Road Supervisor: This does not increase the budget. We are wanting to change the salary schedule from years of service to experience. The guys can not move up until they get their certifications. They will move up from probation, Operator 1, Operator 2 then Operator 3. There will be testing to show the operator is capable of moving up in levels to our standards and maintain that level. If unable to maintain these levels there could be demotion. Our starting pay is \$13.50, we want to have starting pay to \$16.50 to be competitive.

<u>Madam County Manager Barela</u>: The Executive administrative assistant position is \$19.25, other administrative assistant positions in the county have a

starting pay of \$15.75. The request from the Managers office, if this is going to be a salary schedule to be set at \$15.75. That is not taking into consideration Charmen current rate of pay of \$16.88, she will stay at that rate of pay unless the commission chooses to give her an increase now. Operator 3 position is \$18.75, Clarence Romero is at \$19.50, we what to keep that the same.

Leonard Lujan – Road Supervisor: We would also like to change the mechanic position to a labor position at \$15.00 to be able to fill the position and have the extra help so I don't have to move someone from a large project to handle small projects. We are having a hard time finding a mechanic.

<u>Chairman Schwebach:</u> Motion the approval of amendment to Road Department Salary Schedule as presented, changing mechanic position to labor position, administrative position salary stays the same and leave Clarences salary as is. <u>Commissioner McCall</u>: Seconds the motion.

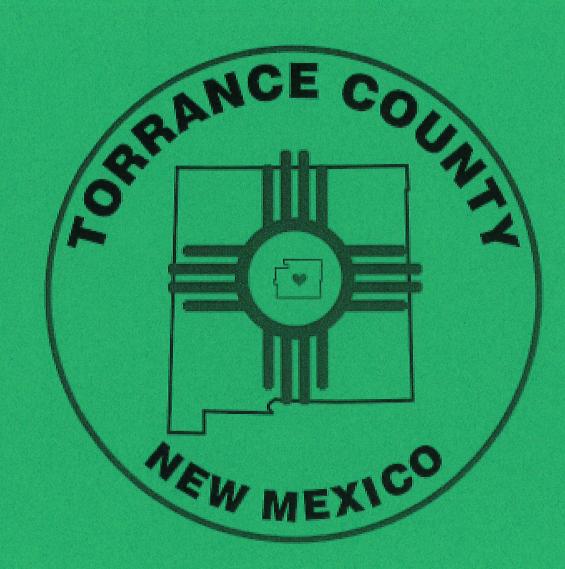
