Precinct 3
Beginning at $4^{\text {th }}$ of July Rd and Capilla Peak Rd; East to State Hwy 337; South to La Mantosa A012; East to Rosewood; North on Rosewood to State Hwy 55: East on State Hwy 55 to Riley Rd; South to A005 Ten Pines; West to Bo77; South to A001 Absher Rd; West on A001 Absher Rd to Capilla Peak Rd; West on Capilla Peak Rd then North to $4^{\text {th }}$ of July Rd

Precinct 7
Beginning at the County Line and A083; East to Hwy 41; North to A090; East to A149; South to A080; East one mile to A071; South on A071 to A068; West to State Hwy 41; South to A038; West on A038; North A044; West A055; North A072 then 1 mile East; North on County Line to A083.

## Precinct 13

Bordered on the North by the Torrance/Santa Fe County Line; On the East by State Hwy 41 to McNabb Rd; McNabb Rd West to Lexco Rd; Lexco Rd North to Route 66 to Torrance/Santa Fe County Line.

## Precinct 14

Beginning at State Hwy 41 and Alan Ayres; East on Alan Ayres to A131; North to A080; West to A071; South to A068; West to State Hwy 41 South to Alan Ayres.

Precinct 15
Beginning at the Torrance/Bernalillo County line and Lexco Rd 11/2 miles East 1 mile north to Walker Rd; East to State Hwy 41; South to Saline Pump Rd; West to Torrance/Bernalillo County line north to Lexco Rd.

## Precinct 16

Beginning at Crest Line Trail and County Line; East to A072S; South to A055; East to A044; South to State Hwy 55; West to Rosewood; South to La Mantosa A012; West to Hwy 55; North to $4^{\text {th }}$ of July and Capilla Peak Rd; North on Forest Rd 321 to County Line.
