

## TORRANCE COUNTY RESOLUTION NO. 2006-38

A RESOLUTION CONCERNING "WHETHER TORRANCE COUNTY SHOULD IMPOSE A COUNTY INFRASTRUCTURE GROSS RECEIPTS TAX OF ONE-EIGHTH OF ONE PERCENT (.125%) ON PERSONS ENGAGING IN BUSINESS IN THE COUNTY AREA OUTSIDE THE BOUNDARIES OF ANY INCORPORATED MUNICIPALITY FOR THE COUNTY GENERAL PURPOSES; PAYMENT OF GROSS **RECEIPTS TAX REVENUE BONDS; REPAIR, REPLACEMENT, CONSTRUCTION OR** ACQUISITION OF ANY COUNTY INFRASTRUCTURE IMPROVEMENTS; ACQUISITION, CONSTRUCTION, OPERATION OR MAINTENANCE OF SOLID WASTE, WATER FACILITIES, WASTEWATER FACILITY, SEWER SYSTEM AND **RELATED FACILITIES; ACQUIRING, CONSTRUCTING, EXTENDING, BETTERING, REPAIRING OR OTHERWISE IMPROVING OR OPERATING OR MAINTAINING** PUBLIC TRANSIT SYSTEMS OR REGIONAL TRANSIT SYSTEMS OR AUTHORITIES; PLANNING, DESIGN, CONSTRUCTION, EQUIPPING, MAINTENANCE OR OPERATION OF A COUNTY JAIL OR JUVENILE DETENTION FACILITY; PLANNING, ASSESSMENT DESIGN OR OPERATION OF A REGIONAL SYSTEM OF JUVENILE SERVICES, INCLUDING SECURE DETENTION AND NONSECURE ALTERNATIVES, THAT SERVES MULTIPLE CONTIGUOUS COUNTIES; PLANNING, DESIGN, CONSTRUCTION, MAINTENANCE OR **OPERATION OF MULTIPURPOSE REGIONAL ADULT JAILS OR JUVENILE** DETENTION FACILITIES; HOUSING OF COUNTY PRISONERS OR JUVENILE OFFENDERS IN ANY COUNTY JAIL OR DETENTION FACILITY; OR SUBSTANCE ABUSE, MENTAL HEALTH OR OTHER PROGRAMS FOR COUNTY PRISONERS OR **OTHER INMATES IN COUNTY JAILS OR FOR JUVENILE OFFENDERS IN COUNTY** OR REGIONAL DETENTION FACILITIES; FURTHERING OR IMPLEMENTING ECONOMIC DEVELOPMENT PLANS AND PROJECTS; RECONSTRUCTION OR IMPROVEMENT OF ROADS, STREETS, OR BRIDGES, INCLUDING ACQUISITION **OF RIGHTS OF WAY** 

WHEREAS, it is necessary for the Board of County Commissioners of Torrance County, State of New Mexico to pass a resolution calling for the placing on the election ballot the question and;

WHEREAS, said question must be approved by a majority of the voters in the county at the General Election to be held on November 7, 2006 and;

WHEREAS, this question is required to be placed on the election ballot by Section 7-20E-19, NMSA (1978 ED.).

**IT IS THEREFORE RESOLVED** by the Board of County Commissioners of Torrance County, New Mexico that the question first stated herein be placed on the General Election ballot to be held on November 7, 2006 **DONE** this 26<sup>th</sup> day of July, 2006, in Estancia, Torrance County, New Mexico.
