RESOLUTION DESIGNATING THE POLLING PLACE OF EACH PRECINCT IN TORRANCE COUNTY, NEW MEXICO

WHEREAS, Section 1-3-2 NMSA 1978 requires that the Board of County Commissioners designate the polling place of each precinct in Torrance County no later than the first Monday in November of each odd numbered year; and

WHERAS, the attached Exhibit "A" designates the precincts and polling place of each precinct in Torrance County. Each polling place shall be accessible to individuals with physical mobility limitations pursuant to statute.

NOW, THEREFORE BE IT HEREBY RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TORRANCE COUNTY that the polling place for each precinct in Torrance County is hereby designated on the attached Exhibit "A"

Dear Precinct 9 and 10 Registered Voter,

This letter is to inform you that your polling place has been moved to the Dr. Saul Community Center which is located at 111 Roosevelt, Mountainair, New Mexico. You will still remain separate precincts but voting in the same building which is allowable by state statute. I feel that this will be a more convenient place because it is centrally located in the Town of Mountainair and it is a town government owned building which makes it a more accessible place for me for scheduling delivery of voting machines and supplies and for access for my precinct officials on Election Day without interrupting anyone's schedules. Also the Town of Mountainair has built a new accessible ramp for those with disabilities which is closer to the entrance of the building for your convenience.

I will have signs at your old polling places directing everyone to the new polling place if anyone registered at these precincts does not get or read this letter. At the new site we will have signs which will direct you to your proper precinct officials and we will have dividers to separate the two precincts.

Primary Election Day is Tuesday June 5, 2018 from 7:00 AM to 7:00 PM. Absentee by mail voting begins on May 8, 2018. If you would like to have a ballot delivered to your home just call my office at 544-4350 to request an absentee ballot. Voting in person also begins on that day in the County Administrative Offices in Estancia, New Mexico just down the hall from my office.

The County Commission approved this new polling place along with all the other precincts in our county and their polling locations at their November 6, 2017 Special Commission Meeting.
