## RESOLUTION ESTABLISHING SCHEDULE OF FEES FOR ACTIONS UNDER THE COMPREHENSIVE ZONING ORDINANCE AND THE SUBDIVISION ORDINANCE

WHEREAS, the Board of the County Commissioners of Torrance County has adopted a Comprehensive Zoning Ordinance that authorizes and requires the adoption of a resolution to establish fees for zoning actions;

WHEREAS, the Board of the County Commissioners of Torrance County has adopted a Subdivision Ordinance that authorizes and requires the adoption of a resolution to establish fees for subdivision actions;


