FINDS LOT NUMBERED SEVENTEEN (17) OF ANTELOPE SPRINGS 34 SUBDIVISION has upon it rubbish, wreckage, or debris which is a menace to the public 35 comfort, health, peace, or safety; and 36 37 2. ORDERS D FISK, M ETUX (see Exhibits 1, 2 and 3) or other owner, occupant, or agent 38 in charge of Lot numbered SEVENTEEN (17) OF ANTELOPE SPRINGS 39 SUBDIVISION (see Exhibit 3) to remove Debris from said property; and 40 41 3. AUTHORIZES the Torrance County Manager to cause the removal of the Debris and to 42


