Dear Secretary Serna,

The Torrance County Board of County Commissioners (BOCC) approved submission of an application for the Transportation Project Fund (TPF) for the Alan Ayers Road Improvement Project during its regularly scheduled meeting held March 27, 2024. Torrance County plans to chip seal Alan Ayers Road West from HWY 41 proceed West 1 mile to start of project proceed 4.5 miles to Peacock Road, end of project. Torrance County owns the right of way for the remainder of the road.

Torrance County intends to complete the entire project within one year including planning/design/engineering, road prep, paving, signage, and certification.

The BOCC approved the project total cost of \$1,007,777.00 anticipating possible fluctuation in costs due to inflation and general price increases. The Department of Transportation's 95% match equals \$957,388.15 and the Torrance County's 5% match equals \$50,388.85. Torrance County has funding available to cover costs exceeding the total award. The BOCC approved the 5% match. Torrance County will not apply for hardship (match waiver).

Torrance County will not use any federal funds to complete the project.
