A RESOLUTION AUTHORIZING THE COUNTY TO SUBMIT AN APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION, LOCAL GOVERNMENT DIVISION FOR THE FY2025 NMDOT TRANSPORTATION PROJECT FUND PROGRAM FOR CHARLIE BRECKENRIDGE ROAD, TORRANCE COUNTY, NEW MEXICO

WHEREAS, Torrance County and acting by its Commission, is in support of seeking funding assistance, in part for the application of asphalt overlay to be applied to Charlie Breckenridge Road for a distance of 1.5 miles; and

WHEREAS, the total requested amount will be \$361,553.12, the Department of Transportation's 95% match equals \$343,475.46 and Torrance County's 5% match equals \$18,077.66; and

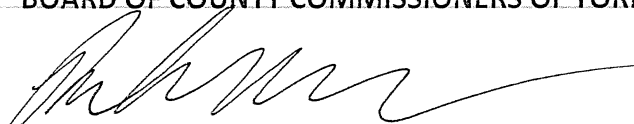

WHEREAS, the New Mexico Department of Transportation requests as part of the application procedure, passage and submittal of a local government resolution of support for the project,

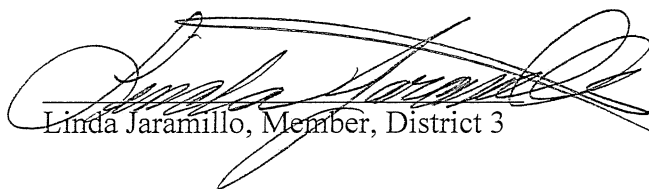

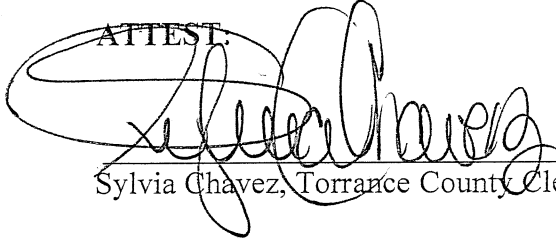

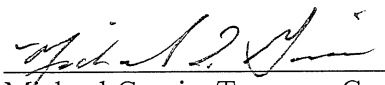
