**A RESOLUTION APPROVING AN EXTENTION OF TIME
FROM THE NEW MEXICO DEPARTMENT OF
TRANSPORTATION FOR PROJECT CONTROL NUMBER
HW2L500600 CONTRACT NUMBER D20412**

WHEREAS, Torrance County and the New Mexico Department of Transportation have entered into a joint and coordinated effort; and

WHEREAS, the total cost of the project will be \$125,740 to be funded in proportional shares by the parties as follows:

New Mexico Department of Transportation's share shall be 75% or **\$94,305**

Torrance County's proportional matching share shall be 25% or **\$31,435**

Torrance County shall pay all costs that exceed the total project budget of \$125,740;
and

WHEREAS, Torrance County acknowledges the project for this Cooperative Agreement is adopted and has a priority standing; and

WHEREAS, the agreement terminates on December 31, 2026, and

WHEREAS, Torrance County is requesting a time extension to June 30, 2026

NOW, THEREFORE, BE IT RESOLVED, by the Torrance County Board of Commissioners that this extension of Cooperative Agreement Project SB, control number HW2L500600 with the New Mexico Department of Transportation for LGRF Project for years 2025-2026, is hereby approved.

LOCAL GOVERNMENT ROAD FUND COOPERATIVE AGREEMENT

This Agreement is between the New Mexico Department of Transportation (Department) and Torrance County (Public Entity), collectively referred as the "parties." This Agreement is effective as of the date of the last party to sign it on the signature page below.

Pursuant to NMSA 1978, Sections 67-3-28 and 67-3-28.2, and State Transportation Commission Policy No. 44, and

Pursuant to the Public Entity's resolution that assumes ownership, liability, and maintenance responsibility for the project scope, or related amenities, and required funding to support the Project identified herein, the parties agree as follows:

1. Purpose.

The purpose of this Agreement is to provide Local Government Road Funds to the Public Entity for the Project, as described in Control No. L500600, and the Public Entity's resolution attached as Exhibit C. See:

Pavement Rehabilitation/Improvements blading & shaping on various county roads

The Project is a joint and coordinated effort for which the parties each have authority or jurisdiction. This Agreement specifies and delineates the rights and duties of the parties.

2. Project Funding.

- a. The estimated total cost for the Project is One Hundred Twenty Five Thousand Seven Hundred Forty Dollars and No Cents (\$125,740) to be funded in proportional share by the parties as follows:
