IMPORTANT VOTER INFORMATION FOR THE 2020 GENERAL ELECTION

Dear Registered Voter,

It is entirely **YOUR CHOICE** to vote by absentee by mail or in person at an In Person voting site. Note: Applications must be received in my office no later than **Tuesday, October 20, 2020**. You can also apply for an absentee by mail ballot online at **NMVote.org**.

All ballots requested will be sent out on **October 6, 2020**. Please vote your absentee ballot as soon as you receive it and get it back to my office for processing. You can **mail** your ballot or **deliver it in person**, to our Absentee by Mail Site, In Person Early Voting Site, our Alternate Voting Site and any polling place on Election Day. All these sites are listed below with dates and times of operation. Postage will be paid.

Place your voted ballot in sealed inner envelope place and then in outer envelope with all information required for acceptance. Outer envelope **must be signed**, and you **must give us the last 4 digits of you Social Security Number**.

Ballots must make it back to us by 7:00 PM on election day. **Please do your part in getting your ballot back to us as soon as possible so your vote is counted.**
