- Call To Order- Chairperson Stephen Garret called the meeting to order at 9:04 am.
- 2. Pledge Of Allegiance-Chairperson Stephen Garret led the pledge.
- 3. Welcome and Introductions.
- 4. Determination of Quorum- It was determined that the meeting was two members short of quorum, and the meeting would continue as a working session.
- 5. Approval of Agenda- Unable to approve meeting agenda due to lack of quorum.
- 6. Approval of Minutes-Unable to approve meeting minutes for June and July due to lack of quorum.
- 7. Forest Service Presentation- Christian Larson, District Ranger from the US Forest Service gave a presentation discussing upcoming projects for next spring and early summer. These included projects scheduled for Capilla, Espinosa, Red Canyon and Isleta RX. Prescribed burns are scheduled for the upcoming fall and winter. Christian also discussed lands and special use projects, including

Gallinas Mines remediation, Lincoln County Telecom Tower, removal of the Capilla peak Observatory, and burying the Capilla power lines .

- 11. Agency Updates-
  - Tom Carter of Estancia Police Department was just appointed as Chief.
  - County Manager Janice Barela recently resigned. Deputy County Manager Tracy Sedillo will be retiring September 30<sup>th</sup>. The Human Resources Director will also be resigning, and the position has been posted. Leadership changes will be occurring.
- 12. Agency Presentation- Samantha O'Dell explained the purpose of the LEPC meeting to the new attendees. Chairperson Steven Garret discussed the ERPTC volunteer group and the importance of being proactive with emergency response within Torrance County. Samantha encouraged members to suggest any training and exercises they would like to see in the future.
  - Claunch Pinto Soil and water Conservation, Dee Tarr explained her experience and history with Claunch Pinto, and the water conservation districts in the surrounding counties. She discussed grants and projects used to protect soil and water conservation and the importance of mitigating hazards and collaborating with surrounding agencies.

Samantha also made the group aware that there will be a Tabletop Exercise (TTX) in the upcoming September meeting. An active shooter event was discussed as being an exercise that could be used to collaborate and work with surrounding first responder agencies cooperatively.
