DETERMINATION OF A QUORUM

PRESENTATION (Nuclear Weapons Storage)

- Phillip Gaudette (USAF CMSgt retired).
- KAFB underground munitions storage- largest nuclear weapons storage area in world (KUMMSC).
- Threats to Torrance County- nuclear destruction of site, chemical, biological or EMP- may be used by enemies to gain access.
- Stephen mentioned the need for preparedness not fear- stated that the county needed to prepare. Mentioned the need for iodine pills, radios and fallout shelters.

ENERGY TABLETOP EXERCISE FEEDBACK/UPDATE

- Exercise was set up between Emergency Managers and Electric Co-ops.
- Learned a lot about what each sector does.
- There has been great communication between EM and CNMEC since exercise.
- EM interacted with other co-ops in state and learned how they operate.
- Learned how to support each other- in discussion on what needs to be reported to LE, fire or EM.
- Plans for additional Tabletop exercises in 2026.
- Stephen spoke about recent geometric storms. They could have caused major grid problems if they were sunward.
- Mentioned a good resource: sunweather.com (run by gov't)

EVENT UPDATES

- Samantha showed a couple videos regarding the pipeline explosion in Artesia that took place in October 2025.
- How would that look like in Torrance County in terms of a response from first responders, pipeline owners and citizens.

- Discussion about the vast number of pipelines running through county.
- Tessa sent in a video about a gas leak from a tanker truck in the parking lot at a hotel and how quickly it spread and resulted in numerous injuries, evacuations and shelter in place orders.
- Phillip G. had a question about ERG's. Samantha said she may bring some to next meeting.
- Question about status on radios- Samantha reported the dispatch piece would take 4-6 weeks after purchase order in complete. RFP's on other radios were sent out and a decision will be made by mid-January 2026.
- Discussion about HAM radios- meeting scheduled for mid- December to draft a policy. Radios in dispatch and mobile command need to be tested.

EMERGENCY ALERT UPDATES

- Code Red went down a few weeks ago due to a cyber security issue.
- Torrance County will be contracting with a new provider- TextMyGov. should be up by next week
- If alerts need to be sent out until then, the state has agreed to send those on our behalf.

EVENT UPDATES

• A CHEMPACK webinar will be available to anyone interested on December 17th. It will be presented by the Dept of Health.

AGENCY UPDATES

- Rebecca Elmor reported that on November 8th, the Mountainair Ranger District successfully conducted the largest landscape prescribed burn in years (1300 acres).

- I-40 Corridor Workshop was discussed. The workshop focused on identifying resources, gaps and concerns. Conversations were created and hopes for future workshops.
