In accordance with 19.D. of the Torrance County Zoning Ordinance, no building shall be constructed, nor mobile home installed, within the jurisdiction of Torrance County without first obtaining a Development Permit from the Torrance County Planning & Zoning Office. This form must be completed prior to occupancy or use of any building or mobile home. An administrative fee of \$200.00 (per unit) shall be paid prior to the issuance of this permit.

THIS PERMIT EXPIRES ONE YEAR FROM TODAY'S DATE.

If construction has not been initiated by the one year expiration date, you will need to reapply.

(2 copies) Proof of Water System or State Well Permit
(2 copies) Mobile Home Floor & Site Plans
(2 copies) Title & Registration

(2 copies) EVSWA Pay Stub

(2 copies) NMMHA Set-Up Permit Application

Note: Be sure to check if your property/building pad lies within a floodplain. If so, there are federally mandated procedures that must be followed. Information can be found at www.fema.gov, or check with the Torrance County Planning & Zoning Office. **Torrance County Flood Damage Prevention Ordinance 92-4.**

The mobile home shall be in compliance with Section 6.C. of the Torrance County Zoning Ordinance. Mobile home transporters who move mobile homes into or within Torrance County without obtaining this permit will be subject to prosecution, a \$300.00 fine, and/or 90 days in jail for each offense according to section 5.C of Ordinance 2017-01.
